The Parent/Carer responsibilities

I/We will undertake to:

- Make sure my/our child attends school regularly and on time and not take holidays during term time.
- Communicate with the school any concerns and attend parent meetings.
- Ensure that my/our child wears school uniform and is equipped and prepared for the day
- Help my/our child with their learning at home through regular reading and homework support.
- Support my/our child and the school in responding positively to expectations of the school's behaviour code.
- I/we will support the school approach to online safety and not upload or add any text, image, sound or videos that could upset or offend any member of the school community, or bring the school name into disrepute.
- I/we will ensure that my/our online activity would not cause the school, staff, pupils or others distress or bring the school community into disrepute.
- I/we will support the school's policy and help prevent my/our child/children from signing up to services such as Facebook, Instagram, Snapchat, Whatsapp and YouTube whilst they are underage (13+ years in most cases).
- I/we will close online accounts if I/we/teachers find that these accounts are active for our underage child/children.
